June 2016

Minutes

On Tuesday, June 28, 2016 the Colleegeville Board of Supervisors met for their monthly meeting at the Colleegeville Township Hall. Present were Supervisor Craig Guggenberger, Chair, Supervisor Rick Thompson, Treasurer Bob Simon and Clerk Joe Pohl. The meeting was called to order at 7:00pm by Supervisor Guggenberger.

The Board reviewed the presented agenda. Supervisor Thompson motioned to approve, seconded by Supervisor Guggenberger, motion carried.
