

Monthly Board of Supervisors Meeting
November 2014
Minutes

On Tuesday, November 25, 2014 the Collegeville Board of Supervisors met for their monthly meeting at the Collegeville Township Hall. Present were Supervisor Craig Guggenberger, Chair, Supervisor Dan Kron, Treasurer Bob Simon and Clerk Joe Pohl. The meeting was called to order at 7:01 pm by Supervisor Guggenberger.

Clerk Pohl read the minutes from the October Board of Supervisors Meeting. Supervisor Kron motioned to approve minutes as read, seconded by Supervisor Guggenberger, motion carried.

Clerk Pohl presented payroll and claims for payment. Supervisor Kron motioned to approve payroll check numbers 11432-11442 and claim numbers 10182-10220 for a combined total of \$996,705.60, seconded by Supervisor Guggenberger, motion carried.

Treasurer Simon presented Treasurer's Report. Balance for all accounts is \$333,410.75. Supervisor Kron motioned to accept Treasurer's Report, seconded by Supervisor Guggenberger, motion carried.

Ordinance Administrator Allan Eisenschenk presented the Planning Commission Report.

1. Audrey and Eric Nierenhausen – Application for Conditional Use Permit for a new house 33'6" in height on front side of house and 41'6" in height on rear side of house to allow for lower windows and doors on walkout. Supervisor Kron motioned to approve as recommended by the Planning Commission, seconded by Supervisor Guggenberger, motion carried.
2. Audrey and Eric Nierenhausen – Application for Construction Site Permit for a new house on 260th Street. Supervisor Kron motioned to approve as recommended by the Planning Commission, seconded by Supervisor Guggenberger, motion carried.
3. Stephen Schloemer - Application for Conditional Use Permit for a new house on Hidden Cove Rd with 29'11-3/4" in height on front side of house and 29' 11-3/4" in height on rear side of house. Supervisor Kron motioned to approve as recommended by the Planning Commission, seconded by Supervisor Guggenberger, motion carried.
4. Michelle Coborn – Application for Construction Site Permit for a 48' x 80' accessory building for personal storage and greenhouse for growing plants. Supervisor Kron motioned to approve as recommended by the Planning Commission, seconded by Supervisor Guggenberger, motion carried.

Location of share-the-road sign on Island Lake Road near Knightwood Rd was discussed.

Treasurer Simon gave an update on the sand/salt shed.

Quote from Diamond Mowers was reviewed.

Supervisor Guggenberger gave an update on a recent Chain of Lakes Fire Department meeting he attended.

Board of Audit meeting is scheduled for January 20th.

Supervisor Kron motioned to adjourn at 9:04pm, seconded by Supervisor Guggenberger.
