## Monthly Board of Supervisors Meeting

August 27, 2019

On Tuesday, August 27, 2019 the Collegeville Board of Supervisors met for their monthly meeting at the Collegeville Township Hall. Present were Supervisor Terry Stein, Chair, Supervisor Craig Guggenberger, Vice Chair, Supervisor Rick Thompson, Treasurer Bob Simon and Clerk Joe Pohl. The meeting was called to order at 6:58pm by Supervisor Stein.

The Board reviewed the presented agenda. Supervisor Guggenberger motioned to approve the agenda, seconded by Supervisor Thompson, motion carried 3-0.

The Board reviewed the July 2019 Board of Supervisors Meeting minutes. Supervisor Thompson motioned to approve the minutes as submitted, seconded by Supervisor Guggenberger, motion carried 3-0.

The Board reviewed the August 12, 2019 Additional Board Meeting minutes. Supervisor Guggenberger motioned to approve the minutes as submitted, seconded by Supervisor Thompson, motion carried 3-0.

Payroll and claims for the month were reviewed. Supervisor Guggenberger motioned to approve check numbers 13299-13325, for a total of \$99,846.30, seconded by Supervisor Thompson, motion carried 3-0.

Supervisors reviewed the Treasurer's Report. Balance for all accounts is \$463,255.61. Supervisor Thompson motioned to approve the Treasurer's Report, seconded by Supervisor Guggenberger, motion carried 3-0.

Craig Wensmann from Bogart, Peterson and Associates was present to introduce himself and share the services his company offers.

Ordinance Administrator Allan Eisenschenk presented the Planning Commission Report.

1. Barry & Barb Lieski - 29289 Lindberg Lane, Avon, MN, Application for Construction Site Permit for new house and attached garage. Supervisor Guggenberger motioned to approve as recommended by the Planning Commission, seconded by Supervisor Thompson, motion carried 3-0.
2. Henry & Angel Blattner - 29642 County Rd 9, Avon, MN, Application for Construction Site Permit for an Accessory Building 32ft x 48ft x 14ft high sidewalls and 20ft structure height. Building to be used for personal storage. Supervisor Thompson motioned to approve as recommended by the Planning Commission, seconded by Supervisor Guggenberger, motion carried 3-0.
3. Dan Reisinger and Clara Knutson - xxx County Rd 50, St. Joseph, MN. Requesting a Letter of Compliance for a Land split of 133.84 acres into a 102.75 acre parcel and a 30.01 acre +/- parcel. Supervisor Guggenberger motioned to approve as recommended by the Planning Commission, seconded by Supervisor Thompson, motion carried 3-0.

Sue Eich and other residents from the Big Fish Lake area were present to discuss the possibility of additional no parking along Big Fish Lake Road. Currently there is no parking on both sides of the road near the public access and no parking on the south side of the road between Jennifer Drive and Schulz Road. No action on this matter.

Discussions were made on rocks in the road right-of-way (ROW) on Hidden Cove Road at 27723. The ROW at this portion of the road is 33 feet or 16-1/2 feet from the center of the road. Clerk Pohl will send a letter to the property owner requesting removal of the rocks. There are also rocks and a fence in the ROW at 27785. Clerk Pohl will send that property owner a letter as well.
